The RFP allowed for multiple vendor awards that consisted of a primary and alternate vendor award by product category. Three vendors submitted responses and were evaluated, of those three vendors, Patriot Solutions, LLC's response consisted of reselling Evenflo brand products at markup pricing which made their pricing much higher than the other two vendors; therefore, they were not considered for award.
