# **SCORING**:

Responses were scored according to the RFP's Evaluation Criteria across two technical evaluation stages, in addition to the cost evaluation. Detailed scoring information can be found in the Data Communications Award Justification Statement posted on the NASPO ValuePoint <u>Data Communications portfolio landing page</u>.

# **AWARD**:

The RFP allowed for multiple vendor awards in each award category based on each vendor's success in earning more than 70% of the maximum 666.7 points possible during the scoring process. Nine (9) of the 29 vendors evaluated received 466.69 or more points in one or more categories, making them eligible for award.
